**RESOLUTIONS - DO YOU WANT TO CONTRIBUTE TO THE DEMOCRATIC PROCESS?
AN OPPORTUNITY TO MAKE YOUR VOICE HEARD WHERE IT MATTERS!**

County party members are encouraged to write a resolution(s) relating to an area of governance that they are interested in for possible inclusion to the DPW platform. What area of your world are you passionate about that you would encourage the DPW and Democrats to work to change or work toward? This is your chance to tell the state party your thoughts!

Resolutions can be no more than 100 words, not already included in the platform and must be structured as follows:

WHEREAS, (Factual statement and observations)

WHEREAS, (More factual statements and observations); and

WHEREAS, (More factual statements and observations).

THEREFORE RESOLVED, that the Democratic Party of Wisconsin (or you could write DPW) supports (statement).

Each resolution will be assigned to one of four general topics:

- Justice, Human Concerns and Democracy
- Education, Labor & Economics
- Foreign Affairs
- Agriculture & Environmental Affairs.

The following is a sample of a resolution submitted by PCDP and adopted by the DPW in the past:

JUST CAUSE FOR ALL EMPLOYEES (80 words)

WHEREAS, workers and employees are the lifeblood of a thriving economy, and

WHEREAS, employees need protection from discrimination, persecution and wrongful dismissal, and

WHEREAS, employers need protection from litigation resulting from wrongful discipline, and

WHEREAS, employment is of great value to both the employer and the employee, therefore, neither should have that employment placed in unnecessary jeopardy.

THEREFORE RESOLVED, the DPW supports that no employee who has completed a probationary period should be disciplined, suspended or discharged without just cause.

While the opposition party met in Madison in a lame-duck session to curtail the powers of the newly elected Constitutional Democratic officers, Governor-elect Tony Evers proved that there would be a new agenda in Wisconsin. Totally unheard of during the previous administration, Governor-elect Evers announced things would be different during his tenure by inviting Wisconsin citizens to a budget listening session where he would be doing the listening.

PCDP member Lynn Wyman sent this article about the event.

Governor-elect Tony Evers held a budget listening session in Wausau at the Labor Temple December 12, 2018. It was the second of 4 sessions held throughout the state. More than 200 people attended the Wausau session and at least 6 of those were members of Portage County Democratic Party.

The Governor-Elect made brief remarks before participants were split into 5 discussion groups: Children’s issues, Health Care, Criminal Justice Reform, Labor and Workforce Issues, and Environmental concerns.

Information collected at these sessions will be used to prepare the next state budget.
