Governor Evers & Lieutenant Governor Barnes traveled to UWSP on April 3 for the first of several public listening sessions on the "Peoples Budget". The gathering was held in the Laird Room of the Dreyfus Center on the UWSP campus, where the Governor was introduced by Representative Katrina Shankland.

Governor Evers opening remarks indicated that this listening session was a follow up to the listening sessions he held around the state shortly after he was sworn into office. He crafted his State Budget based on what the people of Wisconsin indicated was important to them during those sessions.

People attending the follow-up listening session could choose to participate in any one of the 6 discussion groups featured in the budget; higher education, health care, criminal justice, economic development, transportation, and natural resources.

Each group included a facilitator, a note taker (from the Governor's office) and an individual available to read the actual wording of the proposals in the budget. Citizens were encouraged to comment on the budget proposals, make further suggestions and to encourage their legislators to support the People's Budget.
