

There are two races in the August election with two Democrats running for the same seat.

Partisan means that you may only vote for candidates from one political party in that election.

#### **DEADLINES:**

**August 7, 2020** @ **5:00 p.m. -** Deadline to Register in Your Municipal Clerk's Office- Voters may register in-person in their municipal clerk's office during the clerk's business hours until 5:00 p.m. on August 7, 2020.

August 11, 2020 from 7:00 a.m.-8:00 p.m. - Register to Vote at Your Polling Place- Voters can register to vote at their polling place on Election Day, August 11, 2020.

**August 9, 2020 -** *Deadline for In-Person Absentee* - Voters can possibly request and vote an absentee ballot in-person in their municipal clerk's office through August 9, 2020. **Office hours vary by municipality** <u>Please contact your municipal clerk for absentee voting hours</u>.

**August 11, 2020** @ **8:00 p.m. -** *Deadline to Return Absentee Ballot -* You must return your absentee ballot by mail or delivery to your <u>municipal clerk</u>, your polling place, or a local dropbox established by your clerk. Your ballot must be received by your municipal clerk no later than 8:00 p.m on August 11, 2020.

#### Our Elections Administrators Need Your Help! submitted by Jerod Barkley

The stakes could not be higher in 2020. In order for us to defeat Donald Trump, every eligible voter in Wisconsin must have an opportunity to vote. That's why we're encouraging our advocates and volunteers to not only vote but to go the extra mile and serve as a poll worker. The partisan primary election is Tuesday, August 11th, and the general election is on Tuesday, November 3rd.

We must ensure this election runs smoothly, with every eligible voter able to cast a ballot that counts. That takes election workers who:

- Provide a positive voting experience
- Check in and register voters
- Assist with the voting equipment
- Answer questions

Will you serve as an election worker?

- No experience necessary
- Training provided
- You will be paid!
- Pay rate varies according to municipality.

We need YOU to step up, if you're healthy and have checked with your doctor about risk factors. Municipalities are struggling to retain their veteran poll workers, many of whom are over the age of 65, and, without a new generation of poll workers to step up, they will not be able to keep polling places open. We know it's an uncertain time and many of us are trying to keep our distance socially. We understand if you have concerns and respect whatever decision you make. However, the state elections commission and local clerks are all working with public health officials to develop strong protocols that will ensure our polling places are as safe as possible for voters and election workers. They're purchasing PPE, sanitization supplies, and single-use implements for marking ballots.

If you are unable to be a poll worker, we also are looking for volunteers to be poll observers. Poll observers are the eyes and ears for Wisconsin Democrats' Voter Protection team at an assigned polling location and the first line of defense against any concerted efforts to confuse and deter voters. #### **2020 PCDP PICNIC GOES VIRTUAL 8/23/2020** Rick Christofferson

The Portage County Democratic Party picnic is an event that goes back decades. Every fourth Sunday in August Democrats and progressives have gathered at a local park for good times together – food and drink, a bake sale, a silent auction, a raffle and to hear from Democratic officeholders and candidates.

This year, we reached a difficult decision that we could not hold our traditional picnic in the building at Pfiffner Park. We worked with the City of Stevens Point and determined that under the reasonable safety guidelines the city proposed we could not have a picnic with sustainable social distancing and other safety measures.

So, we are going virtual this year. The <u>2020 Portage County Democratic Party picnic will still be on the fourth Sunday in August – August 23 – but it will be online via Zoom.</u> Zoom is an online platform that supports audio and video and we have used it successfully for executive board and general membership meetings.

Some parts of the picnic have been retained for the virtual world. We will still hear from Democratic officeholders and candidates and local officials. We will still hold the raffle drawing from Pfiffner Park and present the Dave Obey Award to a worthy recipient. We will talk about the fall campaign and the work it will take to win in November.

We did have to drop a few of our traditions for the virtual event. We obviously will not be able to sell food and beverages and the bake sale has also been dropped for this year.

After some discussion, we also decided to forego the silent auction for this year. The restrictions and safety precautions we are observing were going to present challenges in collecting auction items, collecting payments, and distributing the items out to the successful bidders.

We hope to bring these picnic events back next year at the park.

The loss of the food and beverage, the bake sale and the silent auction means we will take a bit of a revenue hit this year (acknowledging some of our costs will be a little lower too). But our campaign work will not stop and our need for ongoing revenue to support that work will continue.

We recognize that some of our members might not be able to join us virtually on August 23 and we regret that we will not be able to connect with everyone that day. We still value your membership and support in our shared progressive values and goals.
